Do you agree how things are going in the camping site?

You don't have to assume any great commitment nor economic if you don't want, because the Association is on your service, to united everybody to discuss these problems, and to achieve these objectives on benefit of everyone: clear invoices to pay what corresponds, to control the Administration in all the topics that affect the co-owners, and to achieve the Administration on our service instead of its own benefit.

We do think you want agree with all these topics.
